90<sup>th</sup> General Assembly

## 2015 SESSION OPENS MONDAY

Arkansas's 90<sup>th</sup> General Assembly convenes at noon on Monday, January 12, 2015.

House Speaker-Elect Jeremy Gillam and Senate President Jonathan Dismang have said publicly they are targeting an 85-day session. There is no limit on the length of Regular Sessions in Arkansas, but historically they have ended in early to mid-April. Saturdays and Sundays count as session days, so an 85-day target would be April 6.

Asa Hutchinson will be sworn in as Arkansas's 46<sup>th</sup> Governor at 10:30 a.m. on Tuesday, January 13 in the House Chamber of the State Capitol.

Official public Inaugural events on Tuesday include:

- 8:30 – 9:30 a.m., Inaugural Church Service, Immanuel Baptist Church
- 12:00 – 1:00 p.m., The Inaugural Address, Capitol Steps, State Capitol
- 1:00 – 2:30 p.m., The Governor's Reception, Rotunda, State Capitol

The House of Representatives and the Senate will meet in a joint session at 10:30 a.m. Tuesday, January 13, 2015 in the House Chamber to declare election results, to administer the oath of office to elected constitutional officers, and to hear an address by the Honorable Asa Hutchinson, Governor of the State of Arkansas.

## BILL FILING

Several appropriation bills were filed this week bringing the pre-filed bill totals to 44 in the House and 22 in the Senate, plus some resolutions.

We will review ALL bills filed (typically 2,500 to 3,000) during the session and identify bills we believe will have an impact on businesses and/or the business environment in Arkansas. These bills will be added to our tracking list (historically 500 to 700) in the following categories:

[HB 1003](#)     [Meeks, Stephen \(R\)](#)     Removes prohibitive-cost exemption for public entities installing shielded outdoor lighting, instead creating a waiver process; places requirements on lighting installations for highways and signage, prohibits excessive light trespass, more.

[HB 1004](#)     [Meeks, Stephen \(R\)](#)     Requires utility companies to purchase net excess generation monthly from net-metering customers at the utility's avoided costs of wholesale power minus a 10 percent fee. Requires separate billing and crediting for facilities with a common owner.

<a href="#"><u>HB 1008</u></a>	<a href="#"><u>Murdock, Reginald (D)</u></a>	To amend laws concerning bidding practices for construction of publicly funded projects; to amend laws concerning retainage of funds in construction contracts. (Shell bill)

## **GOVERNOR APPOINTMENTS**

Governor-elect Hutchinson continues to make appointments to state agencies. Here are some that are of interest to business:

- Public Service Commission
  - Ted Thomas will be the new chairman and will join Elana Wills and Lamar Davis who were re-appointed and appointed by Governor Beebe. Thomas replaces Colette Honorable, who was recently appointed by President Obama to the Federal Energy Regulatory Commission. Davis replaces Butch Reeves.
- Insurance Commissioner
  - Rep. Alan Kerr will replace Jay Bradford. Kerr is completing his three terms in the Arkansas House and has owned an insurance agency in Little Rock for many years.
- Arkansas Economic Development Commission
  - Danny Games has been named Deputy Director and charged with conducting a nationwide search for a new Director. Hutchinson has said the salary of the Director needs to be adjusted upward to make the position more competitive. Director Grant Tennille will work as a contract consultant for a while with AEDC. Games replaces Becky Thompson. Games has a degree in economic development, has worked in economic development and is a former president of the Arkansas Economic Developers association.

- Arkansas Oil and Gas Commission
  - Larry Bengal was reappointed as Director
- Arkansas Department of Workforce Services
  - Daryl Bassett replaces Artee Williams as Director

- Arkansas Highway Commission
  - Alec Farmer
- Key Positions Pending
  - Dept. of Finance & Administration, Director Richard Weiss is retiring
  - Workers' Compensation Chief Commissioner, Watson Bell's term expired December 31, 2014
  - ADEQ, Director Teresa Marks retired last fall.
